## **Doggy Daycare Consent Form**

In order to establish a safe and healthy environment for all participants in the daycare program, Neighborhood Veterinary Center requires all dogs to have proof that the required vaccines and tests have been given and are current. Puppies that have not completed their entire series of vaccines may not yet be fully protected therefore owners must accept any risks of infection and illness.

Spay/Neuter: Intact male and female dogs will be allowed to participate in group or activities upon passing a temperament test. No female in heat will be allowed to attend activities or Doggy Day Care.

I certify that all of the dogs listed on this form have received the following vaccines. If vaccines have been given by another animal hospital, records need to be provided prior to the pet's admission to doggy daycare.

\_\_\_\_\_1. I understand that attendance by my dog at Neighborhood Veterinary Center's daycare program involves group play with other dogs. Although our team will closely supervise all pets and a mandatory temperament test for newcomers will be provided at a charge I accept that play behavior, unknown or undocumented aggression, or routine daily activities can lead to altercations and injuries. I assume the risks of and responsibility for the cost to treat any injuries my dog sustains while playing at Neighborhood Veterinary Center Doggy Daycare. I further understand and accept that Neighborhood Veterinary Center and owners will not be held liable for any injuries or deaths related to my dog's participation in doggy daycare.

2. Dogs in Doggy Day Care or boarding, must not exhibit any aggressive behavior for any reason. Any dog exhibiting undesirable behavior will be safely isolated from the rest of the Doggy Day Care and will not be allowed re-admission until such behavior has been modified. We reserve the right to exclude dogs from Doggy Day Care that pose a potential risk to the safety of our dogs and staff.

\_\_\_\_\_3. All pets participating in Doggy Day Care must be in good health and free from communicable diseases. In the event my dog contracts a communicable disease during the time he/she is attending doggy daycare, I accept responsibility for the costs of all treatments. I also agree to withhold my dog from doggy daycare until he/she has been free of any signs of the disease which will be determined by the doctor. Although the risk of acquiring communicable diseases is small, I accept the risk and agree that Neighborhood Veterinary Center is harmless from expenses incurred for treatment.

I understand and agree that if the need arises, emergency medical care for my pet will be sought from Neighborhood Veterinary Center, and I agree to pay all reasonable costs for such treatment. I understand that one of our team members will attempt to call me as soon as the situation is stable, at which time authorization for further care will be transferred to me.

5. The owner agrees that their pet may be videotaped and/or photographed. The facility shall be an exclusive owner to the results and all proceeds of such taping or photography throughout the world, an unlimited number of times in perpetuity, to copyright, to use, and to license to others in any manner. The owner further agrees that their pet may be used in any and all media and the promotion, advertising, sale, publicizing, and exploitation of the facility.

\_\_\_\_\_6. The facility is not responsible for any loss or damage to any additional items you might bring with your dog to our care services. Including but not limited to any bedding, bowls, toys, and/or collars.

I understand and agree my pet may get dirty during Doggy Day Care, the staff will try to keep your pet as clean as possible, but Neighborhood Veterinary Center is not responsible for bathing your pet. If you would like a bath please let a staff member know. The charge for a bath ranges depending on the size of your pet.

I have read this consent and understand that some risk always exists when groups of dogs are allowed to intermingle. I have discussed my concerns about such risks with the Neighborhood Veterinary Center team members and have had my questions answered to my satisfaction.
